**MOTION:** MOVED by Keith Mann that at Clause 4 f) we remove the Note on the bottom and replace it with a new 16 g) as follows: “Membership and Voting eligibility”

SECONDED by Darlene LaRoche. All in favour: motion carried.

**MOTION:** MOVED by Keith Mann that a new section for voting on financial matters at Clause 16 h) be added as follows: “For the purpose of voting at Annual Meetings regarding all financial matters all eligible voters as per Section 5 will be allowed to vote.”  
SECONDED by Eric Steffensen. All in favour: motion carried.

**MOTION:** MOVED by Keith Mann that a new Clause 10 be added as follows:  
“Termination of Service

a) Backed by substantiated evidence, if it is determined that any member of the Executive Committee, with the exception of the Provincial Chairman, or a League Representative, who are not performing their responsibilities as outlined in the Policy and Procedure manual, then by motion from the Executive Committee that individual will receive written or electronic notice give 60 days to comply to their responsibilities.

b) When 60 days notice has been completed and no acceptable improvement has been made then by a majority vote of the Executive Committee, the services of the individual will be terminated.

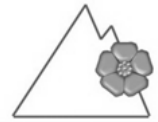
c) Backed by substantiated evidence, if the Provincial Chairman is not fulfilling their responsibilities as outlined in the Policy and Procedure Manual or whose service is a detriment to the organization, then by special meeting or during a regularly scheduled Executive Committee meeting, the Executive Committee will meet with the Chairman to broach the situation and arrive at a solution.

d) When such meetings have taken place and no reasonable progress or improvement has taken place then with consultation and support of the National Board of Governors the Chairman shall be removed from Office.”

e) If a League Representative or a Sponsoring Committee Chairman is not performing their responsibilities as outline in the Policy and Procedure manual or whose services is a detriment to the organization, then by motion from the Executive Committee that individual will receive written or electronic notice given 60 days to comply to their responsibilities. When 60 days has elapsed, and no acceptable improvement has been made then by a majority vote of the Executive Committee, the services of the individual will be terminated.

SECONDED by Darlene LaRoche. CARRIED

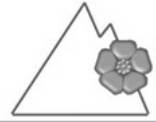

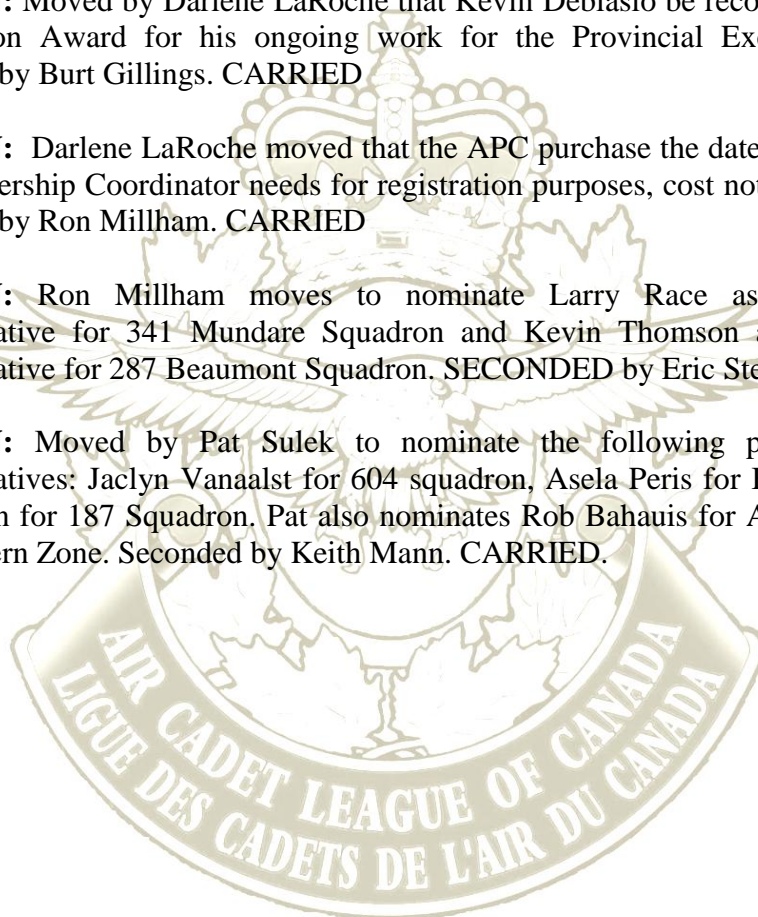

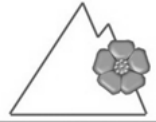

CHAIRMAN'S REPORT *by Fred Johnsen:*

As my third term comes to a close I especially thank all of the Executive Committee including our Governors for their dedication and significant volunteer hours they have put towards the Cadet Program in Alberta and in support of our National Office. It is through their dedication and volunteerism that has made my job much easier and added significantly to the well-being of the Alberta Air Cadet Program. In addition I also say thank you to all the volunteers at the squadron level and our military partners without all of you we would not have the best youth program in Canada.

We the executive initiated numerous improvements over past year;

- Such as the way we conduct our AGM's,
- Running our scholarship boards more cost effective,
- Changed our effective speaking competition to stand alone venue with excellent results.
- Signed several MOU's, which have significantly improved our relationship with key organizations in support of cadet activities and programs.
- Continue supporting the Alberta Top Scholarship Cadets tour 4 Wing Cold Lake during Maple Flag.
- Changed the operating format of Camp Wright, which has significantly increased its usage.
- We have added a recruiting and retention accountability to look at ways to improve how we recruit, retain Cadets and CIC Officers, which is part of our mandate.

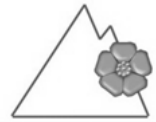
We have challenges:

- We still have squadrons in Alberta that are operating without the required Squadron Sponsoring Committee,
- We still have volunteers working with cadets who are not properly registered and screened – anyone who works with cadets shall be screened, this is also a Province of Alberta requirement for anyone working with youth.
- Our camps are getting older, we will have to spend significant efforts to ensure they remain viable and safe to use.
- There are still squadrons who have not submitted the required ACC 9 - not acceptable.
- Air Cadet League of Canada is currently negotiating with the Department of National Defence to change the cadet supervision requirements to allow registered, screened league members to supervise cadets at non-mandatory cadet activities – stay tuned.

As you are aware I have decided not to let my name stand for another term, in closing I would like to thank all the squadrons I visited for their hospitality and excellent turnout of their cadets, which is my indicator for measuring our Air Cadet Program, all indication demonstrated to me during these visits is that the Air Cadet Program in Alberta is very healthy. Look forward to be able to greet you all at our October AGM 2010 in Calgary.

- **The information form MUST be signed and accompany the ACC9.**

Assessment Fee invoices will be out in December of this year. Sorry that last year's Assessment Fee invoices did not get out until January, 2010 but I was in the hospital for almost a month in November/December, 2009.

DIRECTOR OF AIR RESOURCES *by Eric Steffensen:*

### **Glider Familiarizations and Training**

- Spring and Fall Glider Familiarization flights are flown at the Peace River Gliding Centre (PGC) at Grande Prairie Airport, Edmonton Gliding Centre (EGC) at Villeneuve Airport, Josephburg Gliding Centre (JGC), Netook Gliding Centre (NGC) at Olds, and Southern Alberta Gliding Centre (SAGC) at Vulcan.
- The availability of Josephburg Airport is in doubt due to planned storage yard construction.
- A move from Vulcan municipal airport to the old military airport is still under consideration.
- The Provincial organization has changed so that each Gliding Centre has a Commanding Officer (CO) and an Area Gliding Officer for overall area coordination.
- The number of Cadets qualifying passenger carrying continues to improve. According to the end fall/spring reports, there were 14 cadets that qualified. The achievement award, \$150 for the front seat and \$250 for the rear seat plus the recognition is a successful incentive.

### **Equipment**

- Scout OBW propeller became time expired this summer (forecasted maintenance) and has been replaced with a new propeller. Glider FDR completed the SIRP last winter
- Gliding centres now have eight vehicles and one additional vehicle is being sought. Two older vehicles need to be replaced.

### **Penhold Air Cadet Summer Training Centre Glider Familiarizations Flights - NGC**

- The Penhold Air Cadet Summer Training Centre flew their Glider Familiarization for the Basic Cadets at Netook this last summer using a winch. Over 1200 Familiarization Flights were flown in support of the program.
- Capt Kevin Debiasio did a superb job in keeping the facilities and vehicles clean. He is certainly deserving of recognition for his attention to details and cooperation with the APC.

### **PPS, APPS, GPS**

- Two Alberta Cadets received the APPS in Eastern Region.
- Prairie Region GPS cadets basically finished the course 10 days early and received an introduction to winch launches. 60 Cadets graduated, and there were two RTUs – one medical and one for flying ability.
- Advanced Gliding Program funding was allocated to each region this Fiscal Year. The Pra Rgn Advance Gliding was conducted in Manitoba
- The ACGP long term planning initiatives are ongoing. This year two Alberta pilots received the Advanced Pilot Scholarships and in addition one received funding from the

Power Familiarization program to build flying time to become power familiarization pilot qualified.

**Miscellaneous**

- During the past year, I attended the ACL SAM Ottawa, the DND Flying Training Conference Comox, Gliding CO conference at Gimli, ACL AGM at Regina, PPS graduation at Penhold. The conferences were informative in reviewing the ACGP as to how it can be improved. Since the ACL SAM 2008, I have been serving as the Chair of the National Flying Committee and BOG.
- Charlotte Konechny has volunteered for an Assistant Director of Air Resources position.

DIRECTOR OF CAMP WRIGHT'S REPORT *by Wally Johnsen:*

We have had very successful operating year, our revenue forecast has increased significantly (see attached spread sheet) which is an excellent indicator that we are doing the right things for our customers (cadets). We would not have been able to provide the required service/support without the help of the following dedicated volunteers; Sheila Bella, Cheri and Kevin Lindley-Scott, Leo Lammers, Owners of Barricades and Signs (new gate and directional signs, rebuild fire pit, grading roads), Jeff Fitzser for his contribution and donation (labour and equipment).

I would also thank the following squadrons: 868, 504, 524, for their donations that replaced the curtains in the cabins, new mess hall chairs, lawn mowers, trimmer, etc. Morrison Hershfield Ltd. for the donation of Chairs and Table for the Conference Building and the Maintenance Building.

We have numerous issues coming due to the aging infra structure, such as:

- Replace cabins they are starting become structurally unsafe.
- Replace the grease removal system in the mess hall.
- Replace windows in the mess hall and volunteer building – significant factor in heat loss.
- The old generator building housing the electrical distribution system has to be replaced – dry rot. It is suspected there is a buried diesel fuel tank that has to be removed – potential environmental issue.

We are looking for squadron donations to replace or fix cabins and the grease removal system 5 k +, cabins cost about 17K each – turnkey. We will be forced to close cabins due to safety concerns if we do not start replacing them or temporarily repair floors and roofs in next couple years – which has the potential of reducing the number of beds available to our cadets.

On the positive side have we 1 Canadian Engineer Regiment starting use our Camp for peace keeping exercises and are willing to undertake some repairs as part of their training requirements – stay tuned as it sounds very positive.

We are always looking for volunteers to help with minor maintenance/cleanup – we are there on most weekends – just show up (just phone me or send a email), in the summer bring your camping gear - enjoy pristine Narrow Lake (after chores that is) - great swimming, boating and fishing.

ALBERTA MEMBERSHIP COORDINATOR'S REPORT *by Bev Burke:*

The 2009/10 training year was the best year ever in terms of the number of members registered.

The following are answers to a few questions I have been asked this past year which I thought might be of interest to others:

- **What is required when a person has been registered with an Air Cadet Squadron in another Province or with one of the other cadet elements?**

*They must complete our Membership Application Form so that we have current information for them and indicate the Squadron they were affiliated with and their registration number, if they know it. Once I have confirmed their registration with National, I will issue an Alberta Membership Card based on the term left in their previous registration*

- **Is a current Police Records Check required when renewing a Membership?**

*Yes*

- **How can I rush through a Membership Registration because of a Squadron event?**

*Scan the complete Membership Registration package (all documents) and email or fax them to me indicating how quickly you require it processed. I will rush through the process and advise you of the membership number so that the individual can participate in the event and then once I have received the original documents, by mail, I will issue and mail the membership card.*

- **How recent must the Police Security Check be?**

*While there is no National rule, the Provincial practice is that it must be within the last six months. When the Police Records Check is older than the application, the date of the membership will be the date of the Police Records Check.*

**Incomplete and illegible membership registration packages continue to be a problem.** Documentation must be legible, completed fully, signed where necessary and include the Police Records Check, the completed interview and reference check forms otherwise; it cannot be processed and will be returned causing delays in the issuance of the membership card and increasing costs. Please keep me informed of those members who are no longer active so that we can keep the provincial and national databases current.
